The Secretary, Kannur Municipal Corporation submitted an application for CRZ Clearance for the construction of Groynes near two Sea outlets (Payyambalam and Neerchal) in Kannur Corporation. The proposal was placed in111th meeting of KCZMA held on 23.10.2020 vide agenda item no: 111.03.08 and as per the meeting decision the project proponent was directed to submit the Scientific Modelling Report and the same was submitted. The presentation of the project was made in the 111th KCZMA meeting.

The proposal was again placed in the 112<sup>th</sup> meeting of KCZMA and vide decision No.112.03.08, KCZMA decided to forward the Scientific Modelling Report to Dr.N.P.Kurian, former Director, NCESS for expert advice. Hence vide letter dated 06.01.2021, KCZMA forwarded the Scientific Modelling Report to Dr.N.P.Kurian for expert advice. Vide email dated 08.02.2021, Dr.N.P.Kurian submitted comments on the Scientific Modelling Report.

This was discussed in the 114<sup>th</sup> meeting of KCZMA vide item No. 114.01.02. KCZMA observed that the construction of groynes will not solve the problem of sedimentation of the outfall location unless it is accompanied by dredging operations. The proposed constructions will also disturb the alongshore sediment transport which may lead to accretion in the upstream side and erosion in the downstream locations. For these reasons, KCZMA declined the proposal for the Construction of Groynes near two Sea outlets (Payyambalam and Neerchal) in Kannur Corporation. Vide letter dated 16.07.2021, this was informed to the Secretary, Kannur Corporation.

Now vide letter dated 16.08.2021 the Secretary, Kannur Municipal Corporation (is placed as Annexure- I)requested to review the decision of KCZMA on the following grounds.

i. The study does not predict major, annual dredging. It only suggests that

- the selective dredging on the upstream reaches of the drain which is a minor work.
- ii. The model predicts net deposition on north side of the bund and erosion on its south. This is favourable to keep the channel mouth open and to relieve the area of foul environment created by stagnant water. Shoreline on the South side is covered by rocky pro-monitoring and thus the impact is insignificant. Length of Groynes protruding into the sea is meager compared to the rock cliff projecting into the sea on the south side.
- iii. With deposition on the north side, the tourism beach and the existing walkways will become safer. The groyne itself will become a tourist attraction.

### Illegal Construction by Kattil Mekkathil Temple Authorities- Reg

The Secretary, Panmana Grama Panchayat, Kollam reported that the Panchayat issued a stop memo for the constructions done by Kattil Mekkathil Temple authorities for violating CRZ rules and also KPBR rules. The Panchayat also issued notice to the temple authorities for demolishing the unauthorized buildings on 04.12.2019. But the temple authorities replied that they have not done any illegal constructions. They also informed that due to the soil erosion the distance between the temple and the sea is gradually decreasing and hence the temple is included in CRZ. But the Secretary, Panmana Grama Panchayat reported that the temple authorities have not submitted any substantial documents to prove their claim. The Secretary also reported that all the old and new constructions were done by the temple authorities are included in the CRZ violations list prepared by the Panchayat in compliance with the Judgment of the Hon'ble Supreme Court related to the Maradu Flat demolishing case.

In these circumstances, the Panchayat committee gave direction to Secretary Panmana Grama Panchayat that the actions against the illegal constructions done by 116th Meeting of KCZMA on 20.09.2021- Agenda

the temple authorities are taken only after getting the directions from KCZMA since

the accuracy of the CRZ area is to be verified by KCZMA. Hence the Panmana Grama

Panchayat issued a direction to stop all the actions against the illegal constructions

done by the temple authorities until the directions were received from KCZMA.

The Secretary also reported that all the constructions done by the temple

authorities are in the CRZ III area and also the temple authorities have done the

maintenance and reconstruction of the existing building without getting Clearance from KCZMA. The Secretary also reported that the temple authorities applied for CRZ

Clearance for the regularization of the existing building to the Panchayat. The

Secretary informed that during site inspection it was noticed that the land in which the temple is situated too near to the sea to locate the boundary between the temple

and the sea and also the other buildings adjacent to the temple are not marked in the

plan submitted along with the CRZ Clearance application. Hence the Panchayat

Secretary directed the temple authorities to re-submit the application for CRZ

Clearance by rectifying all the above defects.

The Secretary also reported that the land in Sy.No.18-43/2 (2.60 ares) is only

owned by the temple. But the other buildings of the temple are constructed in the

Purampoku land in Sy.No.43/1 (4.0460 hectors) owned by KMML. The Secretary also

informed that all these constructions are included in the CRZ violations list (Sl.No.32

to 39) prepared by the District Committee formed for preparing the list of CRZ

violations as per the directions from the Hon'ble Supreme Court.

As per the CZMP 2011, the Sy No.18 of Panmana Village is in CRZ limit and

# CRZ Violation of M/S Oyster Opera Resorts in Padanna Grama Panchayat, Kasaragod - Complaint submitted by Sri. Raesan - Report from the District Town Planner - Discussion - Reg

Sri. Ramesan submitted a complaint regarding the CRZ violations of Oyster Opera Resorts in Padanna Grama Panchayat, Kasaragod district to KCZMA. Sri. Ramesan complained that the above resort is constructed by encroaching Kayal. The resort owners have interrupted the flow of Kayal by constructing bund and hence destroyed the natural habitat of fish. Vide letter dated 28.06.2021, KCZMA forwarded the complaint to the District Town Planner, Kasaragod, and Secretary Padanna Grama Panchayat for an urgent report.

Vide letter dated 10.08.2021, the District Town Planner submitted a report regarding the CRZ violations of M/S Oyster Opera Resort. The District Town Planner reported that the resort is situated in Sy.No.94, 266 in Padanna Village in Valiyaparamba Backwater Island. Approximately 12 constructions are situated in this survey numbers including floating cottages, Boat Station, Swimming Pool etc.. and also all the buildings were connected by bamboo bridges, bund etc. The District Town Planner reported that all these constructions are in NDZ of CRZ III and also by encroaching river. Certain constructions are included in CRZ IB also. The resort is owned by Sri.Gul Muhammed.G.S, Smt.P.K.Sarumma and others. The District Town Planner informed that 80th meeting of KCZMA held on 03.12.2016 discussed the matter vide agenda item No.80.02.318 and decided to direct the District Collector, Kasaragod and the Secretary, Padanna Grama Panchayat to take action against the resort as per section 5 of EP Act of 1986. As per the direction of KCZMA, the Secretary, Padanna Grama Panchayat issued notice to the owners of the resort for removing all the unauthorized constructions. The resort owners filed an appeal against

the notice to District Collector, Kasaragod, and KCZMA. The District Town Planner

also reported that the owners of the resort have constructed more buildings and also

renovated the existing buildings even after the notice issued by the Secretary,

Padanna Grama Panchayat. The resort is now functioning.

The District Town Planner mentioned that all the constructions are done

violating the provisions of CRZ Notification 1991 and also CRZ Notification 2011. The

District Town Planner informed that all these constructions are done in NDZ of CRZ

III, CRZ IB, and also CRZ IVB. The constructions of the resort are not permitted in all

these CRZ areas. The District Town Planner also informed that all the unauthorized

constructions of Oyster Opera Resort are reported in the CRZ violations list prepared

by Secretary, Padanna Grama Panchayat from Sl.No.9 to 16.

In these circumstances, the District Town Planner requested KCZMA to direct

the Secretary, Padanna Grama Panchayat to issue a stop memo against the working of

the resort and also to take action against the unauthorized constructions of Oyster

Opera Resort as per section 5 of EP Act of 1986.
