In the petition, it is informed that the illegal sand mining has been continuing for the past 25 years and the seawall constructed by Government has completely collapsed. The regional authorities were informed about the matter and they have not taken it seriously. Hence requested KCZMA to take necessary action to solve the issue and protect the coast. Otherwise, the entire area will get affected by coastal erosion.

The District Town Planner, Kannur was directed to submit a report vide letter dated 21.10.2021 and the District Town Planner reported that the Secretary, Ramanthali Grama Panchayat has given a copy of the petition to the Payyanoor Police Station on 06.07.2021 for taking necessary steps in this regard.

Vide letter dated 10.03.2022 the District Town Planner Kannur has reported that illegal sand mining is continuing in the Ettikulam Beach in Ramanthali Grama Panchayat at night and no action is being taken by police or other authorities.
