<u>Shore Protection Works, Puthuvypeen Coast, Kochi, Ernakulam by the Chief</u> <u>Enginner, Cochin Port Trust, Cochin-9, Ernakulam – Site Inspection Report</u> <u>submitted by Dr.N.P.Kurian-Discussion-Reg</u>

The Chief Engineer, Cochin Port Trust submitted an application for CRZ clearance to KCZMA for shore protection works, in Puthuvypeen Coast, Kochi, Ernakulam. The proposal is for the construction of a series of 23Groynes of lengths varying from 20-500m along a coastal stretch of 3.5km at Puthuvypeen SEZ as long term solution to severe shoreline changes

AGENDA for 126th Meeting of KCZMA on 29.10.2022 The details of the groynes proposed are as follows

- BPCL Shore A series of 14 Rubble mound groynes with lengths varying from 20-75m.
- IOCL Shore A series of 7 Rubble mound groynes, with lengths varying from 20-50m.
- PLL Shore Two rubble mound groynes of lengths 500m and 200m respectively.

KCZMA in its 107th meeting held on 26.02.2020 discussed the proposal in detail and vide decision No. 107.03.17, KCZMA deputed Dr. N.P Kurian, Coastal Dynamic Expert to examine the proposal of Cochin Port Trust and to furnish report to KCZMA. The report submitted by Dr.N.P.Kurian is placed as **Annexure - II**

The 114th Meeting of KCZMA held on 02.07.2021 & 03.07.2021 examined the proposal submitted by Cochin Port Trust and vide decision no. 114.01.01 KCZMA decided to direct the Project Proponent to furnish the revised design and the rapid EIA report incorporating following points.

- 1. It is noted that the input wave data for the first two sites are taken from the Wave Atlas published by National Institute of Oceanography in 1990, which is based on ship observed wave data for the period from 1968 to 1986. The ship observed wave data has inherent defects being visual observations. The data set for the third report is reported to be received from PLL, but other details such as whether it is measured or not are not mentioned. The wave data used for the PLL report appears to be reliable. It is essential that accurate wave data is used for the study. It is learnt that the project proponent has measured year-round wave data of Kochi.
- 2. Sediment grain size data used appears to be inconsistent in some cases as seen in page 23 of the hydrological modeling report.
- 3. Use of Snell's law for computation of breaker parameters is outdated. A wave transformation model incorporating shallow water dissipation of wave energy has to be used.
- 4. More recent equations such as Kamphuis (1191, 2002) and Mils Homens et al. (2013) which are proved to be more reliable should have been considered for Longshore Sediment Transport computations. Further, the computations could be validated with the annual maintenance dredging volumes so as to get more confidence in the computations.
- 5. Shoreline evolution due to the proposed groins has been done sector wise. It appears that the groins in the BPCL and IOCL sites are designed so as to form a transitional groin field. As the study sites are contiguous the shore-

AGENDA for 126th Meeting of KCZMA on 29.10.2022 line evolution with the groins in place has to be predicted for the whole site and decision on the designs made based on the shoreline evolution along the entire coast.

- 6. Need for the 200 m groyne is not convincing; this may be re-examined.
- 7. No study on the structural failure of the 500 m groyne (G1) constructed in 2015 has been carried out. The reasons for the structural failure have to be taken into account in the design of the proposed 500 m groin (G2). Further, an assessment of the functional performance, specifically sand trapping and beach formation, after the construction of the groyne (G1) should be part of the Design Study.
- 8. Geotechnical data should have adequate coverage of the proposed construction site and has to be critically examined to have accurate information on structural settlement. Also, the Design Study should ensure structural stability in the wave breaking zone with specific attention to the cyclones and monsoon waves.
- 9. Though the structures are designed for long term protection of the shore, climate change resilience is not accounted for. As per the Reference Manual on Climate Change Adaptation Guidelines (Black et al., 2019) the projected maximum sea level rise is 38 cm by 2050 and 118 cm by 2100 under a medium sensitivity (RCP 8.5) assessment for Kerala coast. While low-crested groynes are advantageous for the transitional groynes, the 500m groyne has to be designed for climate change resilience. The crest level need not be elevated to the projected climate change resilient levels right now, but the design can have provision for increasing the crest level in future due to rising sea level.

KCZMA has also decided to direct the Project Proponent to arrange for an independent review of structural stability of the revised design.

Moreover KCZMA observed that besides the comments on design of the groyne field the expert appointed by KCZMA has warned that the groyne construction carries significant risk of reduced sediment supply to the coastal sector south of Cochin inlet impacting the shoreline, the parts of which are already experiencing severe erosion. Therefore, the Project Proponent was requested to also consider the revised design options that will not have such impacts or to minimize them.

Vide letter dated 07.06.2022 the Project Proponent, Cochin Port Authority has furnished the layout of the affected stretch of the agencies, the groynes and also requested to accord CRZ Clearance for the Shoreline Protection works at Puthuvypeen Coast and for constructing the groynes stage-wise as proposed. Subsequently vide letter dated 23.06.2022 KCZMA directed the Project Proponent, Cochin Port Authority to furnish a revised report including the following aspects.

- 1. An independent review of the structural stability of the revised design
- 2. Study on structural failure of the 500m groyens (G) constructed in 2015. The reasons for the structural failure have to be taken into account in the design of the proposed 500m groin (G2). Further an assessment of the functional performances specifically sand trapping and beach formation after the construction of the groyens (G1) should be part of the design study
- 3. Revised design and rapid EIA report incorporating all the points communicated.

And vide letter dated 20.09.2022 the Chief Engineer, Cochin Port Authority furnished para wise reply on the queries raised by KCZMA which is placed as

Sri. Rajan had submitted an application seeking CRZ clearance for the construction of commercial (Shop) building in Re. Sy. No. 82/2-2 and 82/2-3 having plinth area of 197.99m² (plot area- 4.43 Ares, FAR - 0.38, Height : 30.60m, No. of floors : 1 through the Secretary, Ambalappuzha South Grama Panchayat. This proposal was discussed in the 125th meeting of KCZMA held on 02.09.2022 and was decided to decline as no new commercial activity is permissible in CRZ III, as per rule.

On further perusal, it was found that the proposal was for reconstruction after demolishing the existing commercial building. <u>Judgement dated 04.10.2019 in WP (C) No. 33556/17 (T) filed by Sri. Ajay</u> <u>Ghosh and removal of unauthorized temporary structures constructed by</u> M/S Shobha Builders violating CRZ norms in Feroke Municipality

M/S Shobha Limited, Kozhikode had submitted a proposal of multistoried special residential building in Sy.No.159/2B (p) of Feroke Village, Kozhikode before KCZMA. The proposal was placed in 73rd KCZMA meeting held on 21.12.2015 (item No. 73.03.97). KCZMA discussed the proposal in detail and decided to intimate that the construction is outside the CRZ limits and prior approval from KCZMA is not required for the area. The decision was communicated to the Secretary, Feroke Panchayat and the Project Proponent vide letter No. 4270/A1/14/KCZMA/S&TD dated 16.02.2016.

Later Sri. Ajay Ghosh filed WP (C) 33556/2017 before the Hon'ble High Court alleging CRZ violation in the construction owned by M/S Shobha Builders in Feroke Municipality. The Hon'ble High Court in its order dated 04.10.2019 in WPC No. 33556/17 filed by Sri. Ajay Ghosh directed KCZMA to conduct the site inspection to find out if it violates the CRZ laws and provisions CRZ notification 2011 contained in any manner. The 104th KCZMA meeting discussed the matter in detail and vide decision No. 104.03.19 decided to depute Dr. Richard Scaria, Expert Member, KCZMA to conduct site inspection. Sri.Toms Augustine, Assistant Environment Officer, Directorate of Environment & Climate Change was also deputed to provide technical assistance. The site inspection was conducted on 30.11.2019. The site inspection report was forwarded to the Standing Counsel for filing affidavit before Hon'ble High Court.

In the site inspection, it was reported that the landscape modifications and construction activities carried out in the No Development Zone of CRZ III of Chaliyar river is in violation of provisions of CRZ Notification 2011.

As per the CZMP 2011, proposed area lies partially in CRZ II category. As per the CRZ status report & CZMP, the construction lies landward to existing authorized road.

This was placed before the 113^{th} meeting of KCZMA held on 15.02.2021 and was decided to defer.

The matter was again placed in the 114th meeting of KCZMA held on 02.07.2021 and 03.07.2021 and decided to direct the Project Proponent to furnish fresh application for CRZ Clearance and connected documents to KCZMA and the Secretary, Feroke Municipality (earlier it was Feroke Panchayat) was directed to take necessary steps to remove unauthorized structures in the NDZ of CRZ III as per CZMP 1996. Hence vide letter no. 45/A2/21/KCZMA dated 18.11.2021 the Secretary, Feroke Municipality was directed to furnish report after demolishing the unauthorized structures in the alleged construction and the Project Proponent was

AGENDA for 126th Meeting of KCZMA on 29.10.2022 requested to submit a fresh/revised application with supporting documents through concerned local body. But the Project Proponent has not furnished the same till date.

Subsequently vide letter dated 08.07.2022 the Secretary, Feroke Municipality has reported that the entire illegal temporary constructions had been demolished by the Project Proponent and the decision of KCZMA in the 114th meeting was thus complied by the Secretary.

Vide letter dated 10.03.2022 and 11.08.2022 Sri.Majo Joseph, Head Commercial Operations M/s Sobha Ltd. has informed that in compliance to the directions of KCZMA, they had removed all temporary structures located within 100 Mtr from the HTL of Chaliyar River and requested to place these documents regarding the removal of temporary structures in the next KCZMA meeting and take appropriate decision. He has also requested to intimate the Hon'ble High Court of Kerala regarding the removal of temporary structures to take a decision and dispose the matter.

In the above circumstances the following matters are before the authority for consideration.

- In compliance to the judgement dated 04.10.2019 in WP (C) No. 33556/17 filed by Sri. Ajay Ghosh and the directions of KCZMA as per the 114th meeting the Secretary, Feroke Municipality has reported that the unauthorized temporary structures constructed by M/S Shobha Builders violating CRZ norms were demolished (vide letters dated 02.03.2022 & 08.07.2022. (Placed as Annexures V).
- 2. The Project Proponent is yet to furnish the revised CRZ application sought by KCZMA as per the decision of the 114th meeting.
- 3. The letter dated 11.08.2022 from the Project Proponent requesting to inform the Hon'ble Court of Kerala regarding the removal of temporary structures to take a decision and dispose the case (Placed as Annexure VI).

OA. No. 159/2020 filed by Sri. K. K. Muhammed Iqbal before the Hon'ble NGT against the "Consent to Establish" – Slaughter Waste Processing Industrial Unit in Survey. No. 57/2, 57/3, 57/4 of Kodungalloor Village in Kodungalloor Grama Panchayat

Sri. K. K. Muhammed Iqbal filed OA No. 159/2020 before the Hon'ble NGT South Zone against the Consent to Establish given by KSPCB for setting up a slaughter waste processing unit in Sy. No. 57/2n57/3 & 57/4 of Kadungalloor Grama Panchayat, Ernakulam District. The Hon'ble NGT in its order dated 25.08.2020 directed the 1st respondent, KCZMA to inspect the area in question and ascertain as to whether there was any violation of CRZ Notification 2011 or 2019 which is in force at the time when the unit was established and if there is any violation, what is the nature of action that proposed to be taken by the KCZMA and submit a report to Hon'ble NGT.

KCZMA in its 110th meeting held on 11.09.2020 discussed the O.A.No.159/2020 and deputed Dr. Thulasidas P. K, Member Expert, KCZMA to inspect the site to ascertain the CRZ status.

Dr. Thulasidas P. K conducted the site inspection on 30.11.2020 and submitted the report to KCZMA. The report stated that the constructed factory building lies in the No Development Zone (NDZ) of CRZ III violating the provisions of CRZ Notification 2011, which is applicable to this case.

The site inspection report was placed in the 112th meeting of KCZMA & vide decision No. 112.04.01, KCMZA ratified the site inspection report and decided to forward the site inspection report to the Standing Counsel. Accordingly, KCZMA forwarded the site inspection report to the Standing Counsel.

Further vide order dated 27.01.2021, the Hon'ble NGT directed KCZMA to file a report regarding the action taken by KCZMA on the basis of the observations made in the site inspection report before the Hon'ble NGT.

As per clause 8 III A of CRZ Notification 2011 that area upto 200 metres from HTL on the landward side in case of seafront and 100 mts along tidal influenced water bodies or width of the creek whichever is less is to be earmakred as "No Development Zone" of CRZ III category. The width of water body adjacent to the constructed buildings is 8-m and the No Development Zone of CRZ III is upto 80 m from the HTL of Periyar river towards landward side.

Being a tidal influenced water body, the constructed building of slaughter waste processing industrial unit by M/s Alliance Marine Products comes under the purview of Clause 8 III A (i) (ii) and (iii) of CRZ Notification 2011. As per the notification, the constructed building in NDZ of CRZ III are prohibited activity. But the project proponent had not submitted any application to KCZMA to obtain CRZ clearance although the project proponent must seek prior clearance from State CZMA for any activity in CRZ area. The Caluse 3(i) of CRZ Notification 2011 states that the setting up of new industries and expansion of existing industries are prohibited activities within CRZ area. Hence, the constructed slaughter waste processing industrial unit building in No Development Zone (NDZ) of CRZ III is violating the provisions of CRZ Notifications, and it cannot be exempted from Coastal Zone Management Plan 2011.

Hence as per the decision of the 113^{th} meeting of KCZMA held on 15.02.2021, notice was issued to the project proponent vide letter of even no. dated 09.03.2021 and also the District Collector was directed to take action against the violation done by M/s Alliance Marine Products.

In compliance of the order dated 23.06.2021 of Hon'ble NGT (SZ) in OA. No. 159/2020, for hearing the project proponent in person (since he was the 9th respondent in the case) before taking a decision in the matter, KCZMA scheduled hearing on 30.11.21 & 10.02.2022. But the project proponent did not appear for the hearing. In the letter dated 09.02.2022 he had stated that he was not aware of any allegations against the unit and no notice has been served to him disclosing any violation of CRZ notification 2011.

Hence as per the notice no. 1495/A2/2021/KCZMA dated 22.02.2022 the project proponent was directed to Show Cause within 30 days of the receipt of the notice, why action as per the provision under EP Act, 1986 shall not be initiated against him. But Sri. Abdul Latheef has not furnished any reply to the notice so far.

Meanwhile Sri. Abdul Latheef has submitted a petition before the Hon'ble Chief Minister in the CMO Portal requesting to exempt M/s Alliance Marine Products and other units in the Eloor – Edayar Industrial area that are facing action alleging violation of CRZ norms.

Hence the matter is placed before the authority for taking a final decision on the violation of CRZ norms and EPA 1986 done by M/s Alliance Marine Products.

<u>CRZ violation in the construction owned by Sri. Kalyan Kumar,</u> <u>Chellanam Grama Panchayat</u>

Sri. Joshy Antony Kurishinkal and other residents of Chellanam Grama Panchayat had submitted a representation in KCZMA against the construction of residential building in Sy. No. 1307 of Palluruthy Village owned by Sri. Kalyan Kumar.

It may noted that as per the decision No. 91.04.03 of 91^{st} meeting of KCZMA held on 17.01.2018 CRZ Clearance was granted for the construction of residential building owned by Sri. Kalyan Kumar in Sy. No. 1307 of Palluruthy village with plinth area 111.58 m², Height : 4.75m subject to standard conditions.

Later the residents of Chellanam Grama Panchayath alleged that Sri. Kalyan Kumar has obtained the CRZ Clearance from KCZMA by submitting forged documents of the existing building through the Grama Panchayat, hence requested to cancel the CRZ Clearance and also to issue orders to demolish the unauthorized construction. AGENDA for 126th Meeting of KCZMA on 29.10.2022 The Secretary, Chellanam Grama Panchayat reported that as per the documents submitted to KCZMA for obtaining CRZ Clearance, the plinth area of the building existed in the proposed area was 112.14sqm. The Secretary has also observed that Sri. Kalyan Kumar has been staying in Chellanam Grama Panchayat and the building that existed in the proposed area was constructed in 1990.

And on further examination of the assessment register it was found that the plinth area of the existing building as per Samchaya assessment register was only 63.78sqm and Sri. Kalyan Kumar is a retired navy official and does not belong to traditional coastal community. It is evident from the title deed no. 1300/16 dated 02.04.2016 of Cochin Municipal Corporation that Sri. Kalyan Kumar has bought the building (with building no.2/116/A) and premises owned by Sri. Louis Thykoottathil.

Explanation from the former Secretary, Chellanam Grama Panchayat and the Section Clerk were sought by the present Secretary. The Section Clerk has stated that the discrepancies in the certificates occurred due to the hectic work in the section.

Several Writ Petitions were filed by Sri. Kalyan Kumar before the Hon'ble High Court for issuing building permit and for resuming the construction works. And favorable orders were issued by the Hon'ble High Court in all the cases.

The order dated 17.07.2018, 19.02.2019 and 21.12.2021 in WP (C)No. 20608/2017, 5000/2019 and 35583/2019 filed by Sri. Kalyan Kumar is **Placed as Annexures VIII.** The present Secretary has reported that he was unaware of the discrepancies in the facts while the cases were considered by the Court.

The matter is placed before KCZMA for taking a decision.

Status of preparation of CZMP 2019

1. Re-categorisation of Coastal Grama Panchayats to CRZ II

The National Coastal Zone Management Authority (NCZMA) in its 45th meeting held on 01/09/2022 recommended that 66 Category-I Coastal Grama Panchayats notified before the issue of CRZ Notification, 2019 be considered "other existing legally designated urban areas" as per the CRZ Notification, 2019 i.e. existing as on the date of issue of CRZ, 2019 Notification. It was submitted that such Category-1 Panchayats met the criteria of built up area and developmental infrastructure and could be considered for classification as falling under CRZ-II area.

It was also decided that the Kerala Government shall provide all the infrastructure facilities in the proposed area as per the norms of Municipality and shall prepare detailed Disaster Management and Mitigation Plans.

The Disaster Management Plans (DMP) of the 66 Grama Panchayats approved for categorization as CRZ – II is required. The plans available in the website of KILA are downloaded. But the plans of the 24 Grama Panchayats (list enclosed) are not available in the website of KILA. Hence the Kerala State Disaster Management Authority has been requested to provide the Disaster Management Plans (DMP) of the above mentioned 24 Grama Panchayats to KCZMA urgently.

Out of the 66 Grama Panchayats 6 Grama Panchayats namely, Ambalappuzha North, Ambalappuzha South, Kottukal, Karumkulam, Chirayinkeezhu and Venganoor which have some atomic mineral reserve are present. Hence M/s Indian Rare Earths Limited was requested to provide the details of the contiguous areas with atomic minerals. The details of the areas with geo-cordinates has been provided and further M/s IREL was requested to provide the shape file of the coordinates provided.

2. Demarcation of Mangrove buffer.

KFRI shared land tenurial status of Mangrove forests of Kollam, Kottayam, Alappuzha, Ernakulam, Thrissur, Malappuram, Kasaragod on 26.10.2022 and the same was forwarded to NCESS and the work of Kozhikode, Kannur is nearing completion.

3. Demarcation of HTL to be done along the bunds/ sluice gates of Kaipad / Pokkali/ Aquaculture ponds

For demarcating the bunds in CZMP, NCSCM shared the template of CZMP which was prepared for Goa State and the sample draft CZMP maps which shows the bund as HTL. NCESS has given the data of bunds of all the Districts which is being verified for further submission to NCESS after certification by Government.

4. IIMP preparation

Guideline for CZMP for smaller islands are awaited from MoEF&CC.

5. Action plan for finalization of CZMP 2019 is enclosed herewith.
