1. Sri.Ambujakshan Nair submitted an application for CRZ Clearance for the renovation of a Theatre building in 20 acres of property comprised in Re.Sy. No. 86/4 of Ambalappuzha Village, through the Secretary, Ambalappuzha South GramaPanchayath. The application was placed before 109<sup>th</sup> meeting of KCZMA held on 24.07.2020 and vide decision No. 109.03.17, KCZMA declined the request for the CRZ Clearance in the Re.Sy. No. 86/4, on the ground that no evidence was seen regarding the existence of building.

2. The Project Proponent submitted a Review Petition before KCZMA and petitioner claimed that a Cinema Theatre in the name and style “Swapna Talkies” was in existence from the year 1968, having a plinth area of 860sq.m and that on account of its old age, it collapsed in the year 2005 that the pillars and the foundation of the said building were in existence. Hence Sri.Ambujakshan Nair requested to review the earlier decision taken by KCZMA on 24.07.2020.

3. The 110<sup>th</sup> meeting of KCZMA held on 11.09.2020 discussed the Review Petition submitted by Sri. Ambujakshan Nair in detail and vide decision No. 110.03.05 of the 110<sup>th</sup> meeting of KCZMA held on 11.09.2020, KCZMA summarily rejected the Review Petition submitted by the applicant as no authenticated supporting/additional documents submitted by the project proponent to reconsider the earlier decision of KCZMA.

4. But Sri. T. Ambujakshan Nair filed WP(c)No. 25621/20 before the Hon’ble High Court against the decision of KCZMA. Vide reference 1<sup>st</sup> cited, the Hon’ble High Court directed the Panchayat to forward the public records regarding the existence of the building for taking a decision by the CRZ Authority, within a period of one month. The Hon’ble High Court also directed KCZMA to take an appropriate decision, in accordance with law, without further delay thereon.

5. Vide letter No. A3-33/21 dated 07.01.2021, the Secretary, Ambalappuzha South GramaPanchayat forwarded the following relevant pages of certain records and reported that the file related to ‘Swapna Theatre’ was destroyed.

1. The professional tax arrear demand register for the year 1988-89.
2. Building tax assessment register for the year 1988-93.
3. Building tax and service tax demand register for the year 2003-2004.
4. Building tax assessment register for the year 1993-94.
5. Theatre checking allowance register.

6. Vide Certificate No. A6/2819/20 dated 21.01.2021, the Secretary, Ambalappuzha North GramaPanchayat certified that as per the Assessment Register for the period 1988-93 the “Swapna Talkies” theatre is assessed in No. 643, 644, 645 having a plinth area of 860m<sup>2</sup>.

7. This was placed before 113<sup>th</sup> meeting of KCZMA held on 15.02.2021 and was decided to defer. The proposal was discussed in the 114<sup>th</sup> meeting of the KCZMA held on 02.07.2021 & 03.07.2021 and as per decision No.114.04.02 KCZMA decided not to grant CRZ Clearance as only reconstruction of the existing building is permissible in CRZ III.

8. Hence, CRZ clearance was declined for the reconstruction of the Theatre building in Re.Sy.No.86/4 of Ambalappuzha Village in Ambalappuzha South GramaPanchayat, Alappuzha District.

9. Now the Project Proponent, Sri.T.Ambujakshan Nair has requested to reconsider the application for CRZ Clearance for the construction of multiple Cinema Theatre in Ambalappuzha South GramaPanchayat. He had requested that the letter dated 07.01.2021 of the Secretary, Ambalappuzha GramaPanchayat has clearly stated the existence of the theater from 1986 to 2005 with a plinth area of 860sq.mtr. The theater building collapsed due to aging and the remains of the old building are still under the ground. It is stated that the drawing for the proposed new theater with a plinth area of 837.sq.mtr and restricting the overall height within 9 mtr as per the new regulation of CRZ has already been submitted by the Project Proponent.

10. The documents submitted by the project Proponent show that the building (cinema theatre) was in existence till 2005. **Condonation of delay in seeking CRZ Clearance for the constructed Residential Buildings**

As per proceedings No. 2665/A1/2019/KCZMA dated 18.03.2020, and vide proceedings No. 1949/A1/2021/KCZMA dated 22.11.2021 KCZMA has delegated power to the District Level Committee of KCZMA to condone the delay in the eligible applications submitted for CRZ clearance for already constructed residential buildings constructed up to 26.02.2020 and 08.11.2021 respectively.

Later several applications for granting CRZ Clearance for the residential buildings already constructed after 08.11.2021 were received in KCZMA. The 123<sup>rd</sup> meeting of KCZMA held on 29.6.2022 discussed the matter in detail and decided to direct all District Level Committees of KCZMA to treat such applications of already constructed residential buildings received up to 29-06-2022, that are otherwise permissible as per the CRZ Notification 2011 as late applications and also to condone the delay based on the merits of the case.

Now KCZMA is receiving a large number of applications seeking CRZ clearance for already constructed residential buildings before and after 29.06.2022. During the public hearing held in 10 coastal districts, a major concern raised by the public was the issue of granting building numbers. Hence, a decision for an extension of time for delay condonation may be taken by giving sufficient time for the general public to apply.
