Status of Coastal Zone Management Plan (CZMP) 2019

The Member Secretary briefed the status of the finalization of CZMP 2019:

- The complaints that require field verification in Alappuzha district were submitted by NCESS and field inspection is to be done.
- The complaints that require field verification in Ernakulam district are yet to be submitted by NCESS.
- The Member Secretary, State Disaster Management Authority (SDMA), and the Director, Kerala State Remote Sensing and Environment Centre (KSREC) were requested to provide data on Dispensaries, Schools, Multipurpose evacuation centers, cyclone shelters, rain shelters, helipads, health center/ hospital, etc in Coastal areas. The data was received and sent to NCESS for incorporation into CZMP.
- The shape file of the fishing villages, wards, etc was requested from the Fisheries department. At present these locations are already marked as point features on the CZMP and if shapefiles are received accurate marking can be done. The shape files of Tourism areas were requested from the Tourism department.

The Member Secretary requested Dr. Reji Srinivas, Senior Scientist, NCESS to present the progress of CZMP modification as per the public hearing grievances and subsequent field verifications.

Dr. Reji Srinivas informed that grievance processing of Ernakulam district is progressing and will be completed by 25-11-2023 Field inspection points will also be finalized by that date. He also informed that after the receipt of all data including spatial data and field data, NCESS would require three weeks to finalize the draft CZMP, land use plan, and report.

After a detailed discussion, the following decisions were taken:

- 1. Filed inspection in the Alappuzha district will be done on the 27th, 28th, and 29th of November, and Ernakulam in the First week of December.
- The data on the presence of bunds/ sluice gates in all the coastal districts will be finalized and sent to NCESS at the earliest
- 3. The observations during field inspection and subsequent corrections made in the map should be incorporated into the public grievances table.
- 4. The observations of field verification done during 2021 by NCESS in all the coastal districts are to be submitted to NCSCM for corrections in the map.
- 5. The data which is to be received from other departments is to be obtained by following up the requests sent and if the data is not available the same has to be communicated to NCESS immediately.
