- 3. Movement of heavy vehicles such as earth-moving equipment should be avoided on the beach.

It is quite alarming that the beaches are now carpeted with construction material wastes and granite stones. It is evident from the photos that the beach characteristics are completely altered and the beach width have reduced to the extent, that the promenade is acting as a proxy sea wall now. In the light of the above experience to prevent further deterioration of the prestigious driving beach ,KCZMA declined to give approval for the development of Character area –II. It is also decided to direct the project proponent to comply with all the conditions stipulated in the CRZ clearance granted for Character-I area and to furnish a full compliance report.
