<u>Issue retalted to the Quilon Educational Trust - Construction of an Engineering College at Adichanalloor, Gramapanchayat on the banks of the confluence of Ithikkara River and Pallimon Thodu (River)</u>

- 1. The Parishthi Samrakshana Ekopana Samithi, Represented by the Convenor, Sri. Odanavattom Vijayaprakash, Kollam filed a writ petition as WR (c) No. 5421/2011 before the Honourable High Court against the construction of buildings for a college with size of 5344m² is being made by Quilon Educational Trust in the land on the banks of Ithikara River. The Kerala Coastal Zone Management Authority, represented by the Chairman, Thiruvananthapuram is the 4th respondent in the said WP. (C). A site inspection was ordered. The Site Inspection report found that the proposed site falls in the CRZ No Development Zone and construction of new building in the site is a prohibited activity. It was also pointed out that dressing or altering the sand dunes, hills, and natural features including landscape is prohibited. The land area has been cleared for making construction. It recommended invoking action under Section 5 of the Environment (Protection) Act 1986 to stop all activities.
- 2. Notice dated 25.03.2011 was issued to the Chairman, Quilon Educational Trust to stop forthwith all construction activities in the CRZ area. Considering the explanation furnished by the Chairman, Quilon Educational Trust, an expert committee was constituted to undertake a detailed assessment of the status of the area based on filed visit, discussion with the various stakeholders and analyses of satellite imageries and other evidences, and provide a comprehensive report. The Report of the Expert Committee is appended. The recommendations made in the report were considered. Direction was issued to the Secretary, Adichanalloor Gramapanchayat not to permit Quilon Educational Trust to resume any construction till requisite clearance is obtained from the Kerala Coastal Zone Management Authority / National Coastal Zone Management Authority / Ministry of Environment and Forests. Direction was issued to the authorities of Adichanelloor, Chathannoor, Chirakkara, Mayyanad Gramapanchayats and Paravur Municipality to take action to stop mining activities from the Paravur Kayal, Ithikkara River and Pullimon (Pallimana) river / thodu immediately and initiate action against those responsible for such activities. They were also requested to comply with the Coastal Regulation Zone rules, while permitting construction and other activities in the kayal, river and the banks and also to initiate action against the violators of Coastal Regulation Zone rules, under intimation to the Kerala Coastal Zone Management Authority. The Ministry of Environment and Forests was informed of the violation and also

requested to clarify on the HTL and CRZ to be made applicable in this case in view of the case pending before the Honourable High Court. The W.P. (c) 5421/2011 is pending.

- 3. In the meanwhile the Quilon Educational Trust filed a writ as W.P. (c) No. 22652 of 2011 with prayer to quash the notice of KCZMA and to declare that the areas in the Adichanalloor Gramapanchayat have not been included in the Coastal Zone Management Plan. The Honourable High Court disposed of the case leaving it open to the petitioner to take up the matter with the Government of India (3rd respondent in the W.P.(C)) who thereupon shall place the matter before the National Coastal Zone Management Authority as provided in the O.M and take decision on the continuance or otherwise of the stop memo shall be taken as expeditiously as possible at any rate within 8 weeks of the receipt of the objection from the petitioner and orders shall be passed after hearing all the parties concerned. A detailed letter was sent to the Secretary Environment & Forests along with the requisite enclosure.
- 4. The matter was discussed in the CZMA in its meeting on 04.01.2012. The Member Secretary, KCZMA attended the meeting. The main submission of the petitioner was to consider the HTL of that of 1996 as per the approved CZMP of Kerala (Map No. 14 A) so that the construction could be undertaken unhindered. The Member Secretary clarified the queries raised by the Chairman NCZMA on the issue. It was observed that they may have to honour the HTL in the approved CZMP of Kerala, as well as that an assessment has to be made on how much the group has progressed in the construction activities at the site. However, it was made clear that the NCZMA can take a position on the above if the KCZMA approves the report submitted by the Expert Committee and make specific recommendation based on that and that NCZMA would communicate to the KCZMA on the above.
- 5. The matter was placed in the 46th KCZMA meeting and the Authority decided to direct CESS to conduct a field visit to determine the CRZ status of the construction with reference to the Map No. 14 A of KCZMP and also measure the width of the river at undisturbed locations. Accordingly the CESS was given directions and the Director MoEF was informed. While the report from CESS was pending, the MoEF informed of the meeting of NCZMA scheduled to be held on 16th July 2012 with request to attend the meeting with relevant documents.
- 6. The CESS report observes that the four pillars for the main structure and a few sheds are the constructions made in the site. The distance of the piled pillars from the present shoreline (on the Pullimon river side varies from 11.6 to 20.7 metres and that of the sheds varies from 3.5 to 43.3 metres. The minimum distance from the present bank of giver / water body to the recent

constructions in the site is 11.6 metres for pillars and 3.5 metres for the sheds. The present scenario is a modified river boundary (mostly increase in width), which happened due to anthropogenic interventions. Two locations which are less disturbed over the past few years were identified for measuring the width of the river. The width of the river is 35 metres at the bridge across Pullimon river / thodu while it is 34.25 metres across Ithikkara river at a location north of the site. The position of structures in the site superimposed on imagery of locations which are least disturbed where the widths of the rivers are measured may also be seen. Further communications received were submitted as part file.

- 7. The judgment in W.P. (c) 22991/2012 disposed the writ petition directing the 2nd respondent i.e., the Chairman, Kerala Coastal Zone Management Authority, Thiruvananthapuram, to take a decision after considering Ext P5 report also, i.e. the report on CRZ situation of the construction by Quilon Educational Trust in Adicharalloor Panchayat, within a period of two weeks from the date of receipt of a copy of this judgment. The petitioner was heard on 09.11.2012.
- 8. Government of India MoEF instructed that the KCZMA may examine the Expert Committee Report and also all possible natural factors for widening of the river / Kayal and send its comments / recommendations to NCZMA within a month to enable them take a final decision on the consideration of the HTL; KCZMA to decide on the stop memo dated 25.03.2011 based on the details of the HTL map, verify the location of the petitioner site with respect to CRZ and the decision of NCZMA referred; KCZMA to take necessary action including issue of direction to the concerned department to take action against the illegal mining and also for the restoration, as far as possible, of the mined area.
- 9. It may be noted that the CESS report was received just before the meeting and the file along with this report was submitted for use in the meeting. The minutes of the NCZMA meeting on 16.07.2012 too has not been received formally.
- 10. The matter is placed before the KCZMA for a decision on the points raised by the MoEF in the above said letter.

The Chairman presented the QET item in the meeting. The issue with the NCZMA and the Court direction was informed.

The KCZMA decided to clear the case from KCZMA side and decided to send the report and
