# Minutes of the 76<sup>th</sup> meeting of KCZMA held at Conference Hall of the Kerala State Council for Science, Technology & Environment, Ssathrabhavan, Pattom at 11 am on 4<sup>th</sup> August 2016

The meeting started at 11 a.m. The Additional Chief Secretary, Environment Department who is the Chairman of the KCZMA welcomed the participants (List of participants attached). After congratulating the new members Chairman pointed out that there are certain clerical mistakes in the Notification dated 10.6.2016 of the Ministry of Environment and Forest. A petition was also received pointing out the mistakes. After deliberation it was decided that immediate action will be taken to rectify the mistakes by writing to the Ministry.

The Principal Secretary, Fisheries Department pointed out that the earlier meetings of the KCZMA has decided to process application pertaining to maintenance and reconstruction of residential units on a soft handle considering the case of poor fishermen community and the government support for housing in the sector. It was decided that the earlier relaxations for repair and reconstruction of dwelling units will continue subject to the condition that no change in the FSI, FAR and plinth area will be allowed. For Government housing schemes an exception will be granted to the tune of 60 M2 as the maximum plinth area.

The meeting discussed the fact that owing to large number of applications received by the KCZMA for the CRZ clearance, the Authority is not in a position to concentrate its attention to the Coastal Zone regulation and monitoring. Members pointed out that in all the 10 districts District Level Managing Committees have been constituted under the Chairmanship of the District Collectors and as per Clause 6 (c) of the 2011 Notification, the District Level Committees can be called upon to assist the KCZMA in carrying out the responsibilities under the notification. It was also stated that Tamil Nadu, Maharashtra, Karnataka are processing the applications with the assistance of the District Level Committees. The Chairman directed Dr. Harinarayanan and the Additional Secretary to study the present practice followed in these states and to present a viable proposal in the next meeting of the Authority.

Based on the complaints raised, The Chairman directed that the agenda items shall be forwarded to all members in time in future in their e-mail id. The Chairman also stated that there are two additional agenda items and it will be numbered as AA.76.03.01 and AA.76.03.02

The Ministry of Environment and Forest states that in this instant case where the property is located in the territorial jurisdiction of Cochin Corporation, a maximum of 2.5 FAR is permissible as defined within the provisions of CRZ Notification 1991 and 2011.

The KCZMA discussed the matter and decided not to enhance the FAR from 1.5 to 2.5, since the maximum FAR as on 19.02.1991 on which the Notification of CRZ was issued by the Central Government was 1.5.

This structure is shown as 4 floors. The Three floors are as following, Ground Floor-TAS control room, 1st floor-Depot managers and office staff, conference room etc 2nd floor- office room. The 3rd Floor is stair room to the terrace. The height excluding stair room will be 10.8m. The construction is permissible in the area as per the provisions of CRZ notification. The Administrative building height need to be reduced to 9m with maximum 2 floors (G+1).

KCZMA discussed the proposal in detail and decided to clear the proposal subject to the condition that the height of the building will be limited to 9 meters.
