Construction of Rebuilt Kerala Initiative – River Training Work at Shiriya in Kasargod by the Chief Engineer, Harbour Engineering Department

The Chief Engineer, Harbour Engineering Department had submitted application for CRZ clearance for the River Training Works at Shiriya in Kasargod District. This proposal was placed in the 120th meeting of KCZMA and was decided to obtain scientific report (Hydraulic Modeling Report vetted by CWPRS, Pune) on coastal structures for control of erosion as per clause 3(iv)(b) of CRZ Notification 2011. Accordingly, the revised model study report vetted by IIT Chennai after incorporating the comments in the vetted report has been submitted by the Chief Engineer, Harbour Engineering Department.

The Project Proponent was requested to make a presentation regarding the project with all details in the 129th meeting held on 30.06.2023. Vide decision No.129.01.02 KCZMA directed the Project Proponent to consider the following aspect and design the project; Changes in the shoreline on either side of the proposed structures should be considered. It is understood that beach formation occurs on the southern side of the proposed groynes at the river mouth and erosion on the northern side. The interventions proposed are rubble mound structures alone. A detailed modelling study should be conducted with the help of any reputed national institute. The design of interventions should consider a combination of hard and or soft structures and should be based on the comprehensive shoreline management plan.

Now vide letter dated 23.08.2023 the Chief Engineer has reported that the Modelling Study Report submitted vide their letter dated 16.03.2023 has already been vetted by the IIT Madras. The Chief Engineer has requested to provide the CRZ clearance for proceeding further on the proposal.

Petition submitted by Artech Lake View Owners' Association alleging CRZ violation near Akkulam lake by Sri.Abdul Salam, Kollam Corporation, 17/1134, Third Milestone, Kilikolloor, Thevalli.P.O, Kollam District.

Artech Lakeview Owners' Association has submitted a petition to KCZMA alleging CRZ violation involving earth filling, leveling of land and destruction of mangroves near Akkulam Lake.

As per the clearance order vide letter No.682/A2/2023/KCZMA dated 19.06.2023 issued by the KCZMA, permission was granted to Sri.Abdul Salam (XVII/1134, Third Mile Stone, Kilikolloor, Thevalli.P.O, Kollam) for the construction of compound wall having a total length of 587.77m with height 1.50m in Re.Sy.No.1873/1, 1873/2, 1874/1-1, 1874/2-1 subject to the following conditions:

1. The purpose of construction should not be altered under any circumstances.
2. The construction should be subject to the existing local town and country planning regulations.
3. Compound wall should not affect the flow of tidal influenced water body.
4. The clearance is issued on the basis of details furnished by the Secretary, Thiruvananthapuram Corporation and he/she should ensure that all the aforesaid conditions are satisfied. If any violation is noticed, the Secretary, Thiruvananthapuram Corporation will be responsible.
5. The Secretary, Thiruvananthapuram Corporation should furnish a compliance report to the above effect in due course.

The Secretary, Thiruvananthapuram Corporation is yet to furnish the compliance report sought. Based on the complaint submitted by the Artech Lakeview Owners' Association, vide letter of even no. dated 26.08.2023 the Secretary, Thiruvananthapuram Corporation was directed to examine and issue stop memo with immediate effect to the Project Proponent to suspend if any

such activities as mentioned in the petition are carried out and to report KCZMA.

Now the Sub Inspector of Police, Pettah Police Station vide letter dated 05.09.2023 has informed that a case bearing number crime.924/2023U/s188 IPC & section 15 of Environment Protection Act 1986 was filed in Pettah Police Station and requested KCZMA to provide attested copies of CRZ clearance issued to Sri.Abdul Salam for the construction of Compound Wall in Re.Sy.No.1873/1, 1873/2, 1874/1-1, 1874/2-1, 571/24 along with the documents submitted by the Project Proponent for producing the same ACJM Court, Thiruvananthapuram. The documents sought by the Sub Inspector, Pettah Police Station has been forwarded by KCZMA vide letter of even no. dated 14.09.2023.

The Secretary, Thiruvananthapuram Corporation has not furnished reply to the letter of KCZMA dated 26.08.2023. The CRZ clearance issued for the construction of compound wall in Re.Sy.No.1873/1, 1873/2, 1874/1-1, 1874/2-1 may be reviewed since there are no authorized structures or existing buildings in the area.
