Decision : A detailed presentation was made by the project proponent and EIA consultant. The Project Proponent and the Consultant have made a presentation regarding the queries raised. After a detailed discussion, the project was approved subject to the following conditions;

- Measures for sediment bypassing and beach nourishment shall be undertaken by the project proponent to alleviate Coastal erosion at Chellanam.
- Project Proponent should contribute to Coastal Protection measures that are being implemented by State Government at Chellanam and a relevant plan be submitted in this regard within three months.

- The Project Proponent shall carry out intensive monitoring with quarterly reporting of shoreline changes to KCZMA. The high-resolution satellite imageries shall be used for reporting the shoreline changes.
- The concept of sub-sediment cell and management units on sediment transportation on either side (upto 20km) of proposed project site shall be carried out;
- The project shall be executed in such a manner that the fishing activity should not be disturbed;
- The mitigation measures submitted in the EMP shall be executed and its compliance shall be reported;
- No dredging is permitted within the project site without prior approval from KCZMA;
- Construction of the proposed groyne structures shall be undertaken conforming to the designs/drawings/plans submitted;
- A technical committee shall be formed by the Project Proponent for regular monitoring of shoreline changes in the Project Area.
- The committee shall meet once every six months and file a half-yearly report on shoreline changes and compliance with other conditions mentioned in the clearance letter to KCZMA.

KCZMA also advises the project proponent to properly evaluate the risks associated in establishing critical infrastructure so close to the HTL and hazard line. As per widely accepted norms, such structures should be located on the landward side much farther from the HTL and hazard line than it is now. Hereafter, the project proponent should not pursue any additional steps to construct hard structures along the coast that alter the natural coastal processes having impacts elsewhere along the shoreline.

2. The Survey of Mangroves is completed except in Kannur and Kasargod districts. A Survey of Kannur and Kasargod also will be completed in 2 weeks.
