Until such positions are sanctioned as per rules, KSCSTE may be requested to engage suitable manpower as aforementioned, on temporary basis.

### Action taken report on the decisions of 54th Meeting held on 15-4-2013

Members have opined that the action on 54.3.6 need to be expedited by entrusting Kollam District Coordinator of the National Service Scheme to conduct awareness campaign. The matter will be coordinated by Dr. K. Padmakumar and Shri. Baby John.

Arising out of the discussion in the ATR on 54.4.1, it was decided that while sending the communication on the same to the DSC, Kannur, 54.4.1 shall be modified w.r.t. the condition (i) stipulated as follows:

(i) There will be generation of brine reject from the desalination process. The reject is nothing but the concentrated seawater, which remains after desalination process and does not contain external elements. The <u>effluent</u> will have high concentration of salt. Therefore, appropriate dilution mechanism shall be in place to reduce the reject to the ambient seawater concentration in situ. The mechanism shall be reported to the KCZMA in writing before proceeding with the installation of the Plant.

With the above modification, the Action Taken Report of the 54th meeting was approved by the KCZMA.

The proposal is for regularisation of a house made by Dr. Francis at Kadappuram Grama Panchayath in Thrissur District. The applicant filed a Writ Petition WP(C) No. 21621/2011 upon the Stop Memo issued by the Panchayath on the reason stated that the aforesaid construction has been undertaken in CRZ. The applicant claimed that this is a reconstruction. The Hon'ble High Court directed the first respondent KCZMA to consider and take appropriate decision on Ext.5 i.e. the application dated, 13.08.2010 after affording an opportunity of hearing to the petition. Pursuant to the hearing the petitioner was asked to furnish application for CRZ clearance with relevant details through the local body concerned. The Panchayath has forwarded the application with their rejection. The Environment Group of KSCSTE has conducted the field inspection and as per the report of field inspection, "The proposed reconstruction is in the NDZ of CRZ III The existing construction is approximately 1500 sq.ft. Proposed reconstruction is with a plinth area of 1250 sq.ft. Reconstruction of existing authorized structure not exceeding existing Floor Space Index, existing plinth area and existing density and for permissible activities under the Notification including facilities essential for activities can be permitted in the NDZ of CRZ III".

The RCZMA discussed the report in detail and decided to permit construction only for permissible activity subject to the condition that the building shall be used strictly for residential purpose.

The copy of the letter informs that the reclamation work at Vallarpadam Island was carried out in early 80s and at that time there was no practice of obtaining Environment Clearance for reclamation and that no documents connected with the reclamation are available in their office. It is also informed that all reclaimed / accreted land either in backwater or sea within the notified limits of Cochin Port would become the sole property of Cochin Port Trust as per Major Port Trust Act, 1963.

The area between the HTL and LTL (intertidal zone) and the water and the bed area between LTL at the bank to the LTL on the opposite side of the bank of the water are also CRZ. No mangroves are found at the banks of the kayal. The proposed developments are partly in CRZ III. The proposed project site and adjoining area close to the kayal is being reclaimed in certain locations. Lay out of the structures/buildings proposed in the referred site are superimposed in the CRZ map. The building is proposed in CRZ III and also in CRZ IV as per the CRZ map

The KCZMA discussed in detail the proposal for construction of apartment building by M/s. Heera Kerala Developers Pvt. Ltd., 'Heera Blue Waters' in Attipra Village, Thiruvananthapuram and noted that there is a disparity in the NOC issued by Pollution Control Board in the built up area approved and proposed in the application for CRZ clearance. It is further noted that the proposed construction falls partly in CRZ area where new constructions are prohibited. The KCZMA decided that the area which was reclaimed by the proponent need to be restored. Construction can be permitted only outside CRZ area. Action against reclamation of lake shall be proceeded by invoking EP Act 1986.

KCZMA was impleaded as the 8th respondent in the Writ petition. KCZMA filed Counter Affidavit in the case on 14.01.2009. Now, the Hon'ble High Court in its Judgement dated, 05.02.2013 dismissed the writ petition for non prosecution as it appears that the petitioner has lost interest in the cause of action. The allegation in the writ petition is of reclamation. The C.A sweared does not seek the court urging cause in the petition and action as per law.

Sri. Johny. S and three others, Kottayathu Kadavu, Thrikkadavoor Grama Panchayat furnished a petition regarding the construction of Star Hotel "ALL SEASON" at the bank of Ashtamudi Lake in Thrikkadavoor Grama Panchayat violating the provisions of CRZ. The KCZMA constituted a Committee for site inspection. The site Inspection Report revealed that the Hotel building was made by reconstruction of an old residential building which had a ground floor only. The reconstruction of the old residential building is permissible for permissible activities subject to the conditions like existing plinth area, FSI and density. The committee found that the above conditions were violated during the construction of the building which is a violation of the provisions of CRZ Notification, 1991. Moreover, as per the approved CZMP the Hotel building lies in the No Development Zone of CRZ III. Further, the committee recommended that the permission for the reconstruction of the building given by the Grama Panchayat without obtaining CRZ clearance from KCZMA should be examined.
